## THE TREVITHICK SOCIETY MEMBERSHIP APPLICATION FORM

### Personal Information

The holding of personal data, whether held on computers, paper or other media, is governed by the Data Protection Act 1998, and The Trevithick Society has a legal duty to protect any personal information we collect from you. We will use your personal information only for the purposes for which you provided it, and will not pass anything on to third parties.

### Subscriptions

Please consider payment by **Direct Debit**, the most convenient method of payment for us. On receipt of your application, the Membership Secretary will add your Membership Number as our reference before sending the completed bankers' order directly to your bank on your behalf. Please note that a Direct Debit allows us to claim (or vary the amount or frequency of) payments from your account. If fees change in the future we no longer rely on you to update your instructions – you can usually do this easily from your bank's web site.

### Gift Aid

You can make a Gift Aid declaration to the Trevithick Society if you are a UK taxpayer by completing the Gift Aid section when making a gift online or setting up a Direct Debit, using our online form, a pre-printed leaflet form or by printing, completing and sending us a paper form. The declaration covers all your gifts to the Trevithick Society in the future, while you remain a UK taxpayer. The declaration also covers any gifts you have made to the Trevithick Society in the last four years, provided that you have been a UK taxpayer throughout that period. In order for the tax to be reclaimed, the gift must come from a source of income that has been taxed by income tax or capital gains tax. Other taxes such as VAT and Council tax do not count. Gift aid cannot be claimed by a charity where inheritance tax has been paid.
